IOMICA currently holds AU\$ 22,080.28* in equity across three separate bank accounts being the EURO account (FR), ANZ Business Saver account (AU) & ANZ Investment/Term Deposit account (AU).

Transactions through this period were limited to the EURO account only, NIL transactions were recorded in each of the ANZ accounts. The account transactions for the EURO account are detailed in this report and relate to Umpire Expenses for the 2020 European Championship (postponed).

The current investment/term deposit with ANZ (AU) is scheduled to mature on 30 November 2020 with interest payment on our deposit of AU\$19,000 expected to be AU\$1,223.57 and will be deposited to the Business Saver account on maturity.
